FINANCIAL POLICIES AND PROCEDURES

- All <u>Summer Workshop Applicants</u> must submit payment along with the registration form.
- To reserve a space without full payment, a 25% deposit is due by April 15, 2017 if space permits.
- Students are required to pay for all classes. The academy is not responsible for classes missed due to illness or time conflicts. Payment envelopes are available for tuition to be paid by mail.
- Class cards are valid for up to 6 months from the date of purchase and cannot be used for Summer Enrichment or Summer Intensive classes.
- Students who withdraw or are dropped from the roster must pay a re-enrollment fee of \$30 plus current tuition and will be responsible for paying any delinquent tuition at the time of re-enrollment.
- A \$30 fee is added to checks returned for insufficient funds and must be reconciled with certified funds (cash, cashier's check, credit/debit card, and/or money order) within 10 business days from the date of verbal or written notification by Dallas Black Dance Academy.
- No personal checks will be accepted after a check has been returned; **cash**, **money order**, **or credit/debit card** will be the only acceptable forms of payment for all future payments.
- There is a \$2.50 processing fee for all credit/debit card transactions.
- Credit for overpayment will be applied to the next tuition payment, costume fee, or recital fee. A refund will
 only be given if the credit cannot be given for the current dance season.
- Parking is allowed in the secured pay lot for \$2. Bring in your parking ticket to the office to pay. You can pay outside with your debit/credit card but the fee may be up to \$5. You may purchase up to 4 parking discount passes at once. They are only valid when classes are in session.
- The Academy is not responsible for lost or misplaced personal property. Please write the student's name in all dance shoes and attire. It is helpful to have a dance bag to keep all personal items in.
- Refunds for the Academy Summer Workshop <u>must be requested in writing within 10 business days</u> of payment. Refund request processing may take 4-6 weeks. There is a 10% processing fee deducted from all approved refund payments. <u>Refunds will not be issued for the Academy Summer Workshop after May 15, 2017.</u>
